National Accounts Estimates of Niue

Gross Domestic Product: 2020 - 2021

1. OVERVIEW

The estimated value of economic activity of Niue's economy in constant (real) prices has continued to fall from \$28.041 million in 2020 to \$26.310 million 2021, an annual movement of -6.17% (see Table 1).






3. GDP in constant prices by Sector (2009 prices): 2011 - 2021

Depicted in the chart below, for each production sector of the economy since 2011 saw the Govt non-market sector continues to be high each year, with the exception of 2018 and 2019. This pattern was expected, considering the level of expenditure which is used for production that took place in Govt various departments.

Although the private enterprises in the formal sector saw significant increase peaking in 2018 with \$10.28 million, this has decreased since the Covid-19 pandemic to an estimate of \$7.32 million in 2021.



4. Contributions by Sector: 2020 and 2021

The two major contributors to the GDP for 2020 and 2021 were from the Government of Niue non-market sector, from 33.75% in 2020 to 37.42% in 2021, and the Private enterprises or businesses contributing 32.28% in 2020 to 27.82% in 2021. Detail contributions of other sectors are shown in Table 2 below.

5. GDP annual growth by sector

The level GDP saw a significant growth from 2013 peaking in 2018 with a 6.49% annual growth. However, this decreased significantly in 2019 with -1.67% annual growth and continued to decrease in 2020 with an annual growth of -4.72% and -6.17% in 2021.

In terms of individual sector growth, positive growth can be seen in the Government non-market sector from -2.94% in 2020 to 4.05% in 2021. The Private enterprises in the formal cash sector has the significant negative movements in 2020 with -8.8% to-19.11% in 2021.



The GDP per capita defined as the output of a country's economy per person. According to the estimates in table 5 below, although the GDP per capita for Niue decreased for both constant and current prices for the 2021 estimates, this still remains high.
